## Section 36.00—Various Departments, Increase of Emergency Funding for COVID-19 Response

Pursuant to the provisions of section 36.00, Chapter 2, Statutes of 2020, the following report is respectfully submitted.

The following augmentations to Budget Act items are needed to provide support to state and local governments to protect the health and safety and reduce the spread of the COVID-19 outbreak:

- \$31,420,000 to item 4265-001-0001 for the Department of Public Health,
  \$30 million of which will be used to lease Seton Medical Center and
  St. Vincent Medical Center through June 30, 2020, to expand the state's hospital capacity and \$1,420,000 to expand capacity at the Department's Richmond laboratory.
- \$10,647,000 to Item 4120-001-0001 for the Emergency Medical Services Authority, \$8,647,000 of which will support the purchase of new ventilators, the refurbishment of ventilators already possessed by the state, and the purchase of IV fusion pumps and \$2 million of which will be used to contract with American Medical Response to provide patient transportation and stand by services.

We concur with the necessity of these changes to the enacted budget and will be approving these augmentations not sooner than 72 hours from the above date.
