Caltrans District 4 strategy and action plan in support of the City of Oakland's efforts on implementing a comprehensive public safety plan to substantially enhance the city.


Following are the actionable items with short-, mid- and long-term actions to assist in uplifting the city.

 a. Work with city officials to potentially further assist local efforts to bolster the use of crime-fighting technology, including through the installation and management of cameras

#### 3. Litter, Landscaping Efforts, Graffiti Abatement, Signage (Maintenance Effort)

- a. Litter Blitz the major corridors (Hwy 880, Hwy 580, Hwy 24)
  - Starting February 7
    - ✓ Feb 7 on NB 880 from the railroad yard to Hwy 80 connector
    - ✓ Feb 8 on SB 880 from Hwy 80 connector to railroad yard
    - ✓ Maintenance will need shoulder closures
    - ✓ Future full ramp closures during daytime or early hours of weekend (4 to 5 hours)











Oakland 5<sup>th</sup> Street Onramp










- Assign six Special People Program crews to Oakland

- d. Signage


## 4. Encampment


- a. Schedule encampment cleanup and removal (posting permanent signage)
  - Frequent Encampment Locations
    - ✓ Oakland Hwy 24 PM 4.12 EB Broadway
    - ✓ Oakland Hwy 77 PM 0.151 NB 880 onramp
    - ✓ Oakland Hwy 580 PM 39.9 High St
    - ✓ Oakland Hwy 580 PM 44.72 Webster St
    - ✓ Oakland Hwy 880 PM 31.3 Broadway
    - ✓ Oakland Hwy 980 PM 0.85 Castro St
- b. Coordinate with the city staff on shelter efforts

## 5. Caltrans Right-of-Way Space

a. Re-initiate discussion with the city staff for available spaces on Caltrans right-of-way







<u>Vacant A</u>: 2 FLAs at I-580 & San Pablo Ave remain vacant due to unreasonably restrictive zoning combined with low current demand.

- <u>Vacant B</u>: 4 FLAs at I-880 Broadway to Oak St remain vacant due to criminal and encampment activities combined with low current demand.
- Vacant C: 3 FLAs at I-880 Fruitvale Ave remain vacant due to restrictive zoning. Only demand is for commercial truck parking, but zoning does not permit. Vacant D: 2 FLAs at I-880 High St vacant due to restrictive zoning. One tenant currently over 1 year into City Planning CUP process to allow truck parking.
- Vacant E: 1 vacant parcel at Hegenberger Rd can accommodate an emergency shelter but requires access improvements. No City interest to date.








- c. Bulk Trash Removal

  - New planting at the Oak Street onramp
  - Improvements are coordinated with the Oakland Alameda Access Project
  - Oak leaves will be painted on structures adjacent to I-880 to aesthetically enhance walls visible to the public
