## **BALDWIN HILLS CONSERVANCY**

**Duties:**

To acquire and manage public lands within the Baldwin Hills area, and to provide recreational, open-space, wildlife habitat restoration and protection, and lands for educational uses within the area.  
(Pub. Res. Code § 32555(a).)

To acquire lands for open space within the territory of the conservancy. (Pub. Res. Code § 32555(b).)

To provide for the public's enjoyment, and to enhance the recreational and educational experience on public lands in the territory in a manner consistent with protection of lands and resources in the area.  
(Pub. Res. Code § 32555(c).)

Study the potential environmental and recreational uses of Ballona Creek and the adjacent property described in subdivision (a) of Section 32553. (Pub. Res. Code § 32556(e)(1).)

Develop and coordinate an integrated program of resource stewardship so that the entire Baldwin Hills area is managed for optimum recreational and natural resource values based upon the needs and desires of the surrounding community.  
(Pub. Res. Code § 32565.5(a).)

Establish policies and priorities within the Baldwin Hills area, and conduct any necessary planning activities in accordance with the purposes set forth in Section 32555. (Pub. Res. Code § 32565.5(b).)

Give priority to related projects that create expanded opportunities that provide recreation, aesthetic improvement, and wildlife habitat in the Baldwin Hills area. (Pub. Res. Code § 32565.5(c).)

The conservancy shall determine acquisition priorities and may acquire real property or any interest in real property within the Baldwin Hills area from willing sellers and at fair market value or on other mutually acceptable terms, upon finding that the acquisition is consistent with the purposes of the conservancy. The conservancy may acquire the property itself, or may coordinate the acquisition with other public agencies with appropriate responsibility and available funding or land to exchange. The overall objectives of the land acquisitions program shall be to assist in accomplishing land transactions that are mutually beneficial to the landowners and the conservancy, and that meet the conservancy's purposes. Neither the conservancy nor the State Board of Public Works shall exercise the power of eminent domain for the purposes of this division. The conservancy shall have the first right of refusal to acquire, at the cost of acquisition, surplus public lands suitable for park and open space

within the conservancy's territory, any may accept private or public lands offered for recreational trails. (Pub. Res. Code § 32567.)

The conservancy may, within the Baldwin Hills area, undertake site improvement projects; regulate public access; revegetate and otherwise rehabilitate degraded areas, in consultation with other public agencies with appropriate jurisdiction and expertise; upgrade deteriorating facilities; and construct new facilities as needed for outdoor recreation, nature appreciation and interpretation, and natural resource protection. These projects shall be directed by the conservancy and undertaken by other public agencies, with the conservancy provide overall coordination through setting priorities for projects and assuring uniformity or approach. (Pub. Res. Code § 32568(a).)

The conservancy shall restrict access on acquired lands that are unsuitable for parks and open-space use by entering into temporary agreements with other state or local public agencies for the protection of public health and safety, resource management and protection, and security. (Pub. Res. Code § 32572.)

Establish policies and priorities regarding the territory within the Baldwin Hills area, and conduct any necessary planning activities in accordance with the purposes set forth in Public Resources Code Section 32555. (Pub. Res. Code § 32573(a).)

Give priority to related projects that create expanded opportunities that provide recreation, aesthetic improvement, and wildlife habitat in the Baldwin Hills area. (Pub. Res. Code § 32573(b).)

The jurisdiction of the conservancy shall include only those lands or other areas that are donate to, or otherwise acquired by, or are operated by the conservancy, that are located in the Baldwin Hills area. (Pub. Res. Code § 32565.)

## **STATE BOARD OF BARBERING AND COSMETOLOGY**

Purpose: To ensure the health and safety of California consumers by promoting ethical standards and by enforcing the laws of the beauty industry.

Authority: Business and Profession Code §§ 7303 et seq.

Appointing Power: Governor – 7 (requires Senate confirmation)  
Senate Committee on Rules – 1  
Speaker of the Assembly – 1

Number: Nine (9)

Special Considerations: Additional statutory requirements for public members shall be as follows under Bus. & Prof. Code §§ 450 et seq.

Qualifications: Governor appoints three (3) public members and the four (4) professional members. (Bus & Prof. Code § 7303(b).)

Senate Committee on Rules appoints one (1) public member. (Bus & Prof. Code § 7303(b).)

Speaker of the Assembly appoints one (1) public member. (Bus & Prof. Code § 7303(b).)

Term: Four (4) years (Bus & Prof. Code § 7303(b).)

Term Limits: No person shall serve more than two (2) consecutive full terms. (Bus & Prof. Code § 131.)

Grace Period: Sixty (60) days (Gov. Code § 1774.)

Compensation: One hundred dollars (\$100) per day, including actual and necessary expenses. (Bus & Prof. Code § 103.)

Notwithstanding any other provision of law, no public officer or employee shall receive per diem salary compensation for serving on those boards, commissions, committees, or the Consumer Advisory Council on any day when the officer or employee also received compensation for his or her regular public employment. (Bus & Prof. Code § 103.)

Meeting Frequency: Shall meet at least two (2) times each calendar year. Boards shall meet at least once (1) each calendar year in northern California and once (1) each calendar year in southern California in order to facilitate participation by the public and its licensees. (Bus. & Prof. Code § 101.7.)

(Bus & Prof. Code § 7312(b).)

Issue licenses to those applicants that may be entitled thereto.  
(Bus & Prof. Code § 7312(c).)

Discipline persons who have been determined to be in violation of this chapter or the regulations adopted pursuant to this chapter.  
(Bus & Prof. Code § 7312(d).)

Adopt rules governing sanitary conditions and precautions to be employed as are reasonably necessary to protect the public health and safety in establishments, schools approved by the board, and in the practice of any profession. (Bus & Prof. Code § 7312 (e).)

Association of Bay Area Governments appoints four (4) city representatives from among the bayside cities in each of the following area: (Gov. Code § 66620(i)(1-4).)

- 1) North Bay – Marin, Sonoma, Napa and Solano Counties;
- 2) East Bay – Contra Costa (west of Pittsburg) and Alameda County (north of the southern boundary of Hayward);
- 3) South Bay – Alameda county (south of the southern boundary of Hayward), Santa Clara county, and San Mateo county (south of the northern boundary of Redwood City)

For the purpose of this title, Member of Legislature, or their alternates (if the alternates are Members of Legislature), shall constitute a joint interim investigating committee on the subject of this title, and as such shall have the powers and duties imposed upon those committees by the Joint Rules of the Senate and Assembly. (Gov. Code § 66621(a).)

The Speaker of the Assembly or the Senate Committee on Rules may appoint a Member of the Legislature or legislative staff to serve as an alternate for a Member of the Legislature appointed to a state board within the Natural Resources Agency in the Member's absence. (Gov. Code § 1304.)

A member, subject to confirmation by the appointing power, may authorize an alternate for attending meetings and voting in the member's absence. Each alternate shall be designated in a written instrument which shall include evidence of the confirmation by the appointing power and the alternate's name shall be kept on file with the commission. (Gov. Code § 66622.)

Compensation: None; allowed actual and necessary expenses.

Each member of the commission or alternate who is **not** a state or federal employee shall receive a per diem of one hundred dollars (\$100) per day, not to exceed a combined total of four (4) days in any one (1) calendar month. (Gov. Code § 66622.)

No member who receives a per diem from any other source for attending a meeting shall receive a per diem under this section for attending the same meeting. (Gov. Code § 66622.)

Meeting Frequency: Not stated in statute.

Bond: Not stated in statute.

Oath: Government Code §§ 1360 – 1363.

Duties: Shall cooperate to the fullest extent possible with the Association of Bay Area Governments; and shall, to the fullest extent possible, coordinate its planning with planning by local agencies, which shall retain the responsibility for local land use planning.

In coordination with local governments, regional councils of government, and other agencies and interested parties, the Commission may develop strategies, as needed, for addressing the impacts of, and adapting to, the effects of sea level rise and other impacts of global climate change on the San Francisco Bay and affected shoreline area. These regional strategies may include, but are not limited to the following:

- 1) Identification of areas that may be subject to erosion, inundation, or other impacts from sea level rise and climate change;
  - 2) Economic and environmental analyses of the benefits and costs of protecting the areas likely to be impacted;
  - 3) A plan that describes how to mitigate and adapt to projected sea level rise and other climate change impacts on the bay and shoreline, including protecting resources from erosion and inundation, and maintaining, restoring, or enhancing the productivity of bay and shoreline environments.

May refuse to issue a registration or license under the chapters it administers and enforces whenever it appears that the applicant may be unable to practice his or her profession safely due to mental illness or chemical dependency. The procedures set forth in Article 12.5 (commencing with Section 820) of Chapter 1 shall apply to denial of a license or registration pursuant to this section.

Purpose: Responsible for planning, developing, and improving facilities on state owned and managed properties, including those on State Parks and Water Project properties. It also provides funding so that local agencies can renew deteriorated facilities or develop new public access as well as furthering environmentally sound boating practices through its clean and green programs.

- To improve the safety, health, and welfare of young people experiencing homelessness in the state.
- To increase system integration and coordinating efforts to prevent homelessness among youth who are currently or formerly involved in the child welfare system or the juvenile justice system.
- To lead efforts to coordinate a spectrum of funding, policy, and practice efforts related to young people experiencing homelessness.
- To identify best practices to ensure homeless minors who may have experienced maltreatment, as described in Section 300, are appropriately referred to, or have the ability to self-refer to, the child welfare system.
- To collect, compile, and make available to the public financial data provided to the council from all state-funded homelessness programs.

## STATE BOARD OF CHIROPRACTIC EXAMINERS

Purpose: To regulate the chiropractic profession in California, and protect Californians from licensed and unlicensed individuals who engage in fraudulent, negligent, or incompetent practice of chiropractic.

Authority: Business & Professions Code § 1000 et seq.

Appointing Power: Governor

Number: Seven (7)

Special Considerations: Members shall be a citizen of the United States and a resident of California for five (5) years. (Bus. & Prof. Code § 1000-1.)

Each licensee member shall have had at least five (5) years of licensure in this state prior to appointment, and each member must have pursued a resident course in an approved chiropractic school or college, and must be a graduate thereof and hold a diploma therefrom. (Bus. & Prof. Code § 1000-1.)

Not more than two (2) persons shall serve simultaneously as members of said board, whose first diplomas were issued by the same school or college of chiropractic, nor shall more than two (2) members be residents of any one (1) county of the state. And no person who is or within one (1) year of the proposed appointment has been an administrator, policy board member, or paid employee of any chiropractic school or college shall be eligible for appointment to the board. (Bus. & Prof. Code § 1000-1.)

Additional statutory requirements for public members shall be as follows under Bus. & Prof. Code §§ 450 et seq.

Qualifications: Governor appoints seven (7):  
1) Five (5) licensee members;  
2) Two (2) public members.  
(Bus. & Prof. Code § 1000-1.)

Term: Four (4) years; each member shall serve until his successor has been appointed and qualified or until one (1) year has elapsed since the expiration of his term whichever first occurs. Vacancies shall be filled for the unexpired term only.  
(Bus. & Prof. Code § 1000-2.)

Term Limits: No person shall serve more than two (2) consecutive full terms. (Bus. & Prof. Code § 131.) The member shall not be eligible for appointment thereafter until the expiration of four (4) years

Special Considerations: No public member may, during the twelve (12) months prior to his or her appointment, have held public office, either elective or appointive, have been a candidate for elective public office, or have been a lobbyist, as defined by the Public Reform Act of 1974.

No current or former officer or employee of this State is eligible for appointment to the commission. (CA Const. Art. III, § 8(e).)

- 3) One (1) of whom is representative of the general population and may include, among other, a retiree, homemaker, or person of median income.

Two (2) members who have experience in the business community:  
(CA Const. Art. III, § 8(b)(2).)

- 1) One (1) of whom is an executive of a corporation incorporated in this State which ranks among the largest private sector employers in the State based on the number of employees employed by the corporation in this State;
- 2) One (1) of whom is an owner of a small business in this State.

Two (2) members each of whom is an officer or member of a labor organization. (CA Const. Art. III, § 8(b)(3).)

  - 3) Senate Committee on Rules shall select one (1) member from the north central coast region and one (1) member from the south coast region.
- (Pub. Resources Code § 30301(e).)

### **Nonvoting Members:**

- 1) Secretary of the Resources Agency, or his or her designee;
- 2) Secretary of the Transportation Agency, or his or her designee;
- 3) Chairperson of the State Lands Commission, or his or her designee. (Pub. Resources Code § 30301(a-c).)

Within forty-five (45) days from the date of receipt of a request for nominations by the appointing authority, the board of supervisors and city selection committee of each county within the region shall

nominate supervisors, mayors, or city council members who reside in the region from which the Governor, the Senate Committee on Rules, or the Speaker of the Assembly shall appoint a replacement.

- In regions composed of three (3) counties, the board of supervisors and the city selection committee in each county within the region shall each nominate one (1) or more supervisors and one or more mayors and city council members;
- In regions composed of two (2) counties, the board of supervisors and the city selection committee in each county within the region shall each nominate not less than two (2) supervisors and two (2) mayors or city council members;
- In regions composed of one (1) county, the board of supervisors and the city selection committee in the county shall each nominate not less than three (3) supervisors and three (3) mayors or city council members;
- Immediately upon selecting the nominees, the board of supervisors and the city selection committee shall send the names of the nominees to either the Governor, the Senate Committee on rules, or the Speaker of the Assembly, whoever will appoint the replacement.  
(Pub. Resources Code § 30301.2(a).)

Within thirty (30) days from the date of receipt of the names of the nominees pursuant to Public Resources Code Section 30301.2(a), the Governor, the Speaker of the Assembly, or the Senate Committee on Rules, whoever will appoint the replacement, shall either appoint one (1) of the nominees or notify the boards of supervisors and city selection committees within the region that none of the nominees are acceptable and request the boards of supervisors and city selection committees to make additional nominations.

- Within forty-five (45) days from the date of receipt of a notice rejecting all of the nominees, the boards of supervisors and city selection committees within the region shall nominate and send to the appointing authority the names of additional nominees in accordance with Public Resources Code Section 30301.2(a). Upon receipt of the names of those additional nominees, the appointing authority shall appoint one (1) of the nominees.  
(Pub. Resources Code § 30301.2(b).)

Any member of the commission may, subject to the confirmation of his or her appointing power, appoint an alternate member to represent him or her at any commission meeting. An alternate may serve prior to confirmation for a period not to exceed 90 days from the date of appointment unless and until confirmation is specifically refused. The alternate shall serve at the pleasure of the member who appointed them and shall have all the powers and duties as a member of the commission, except that the alternate shall only participate and vote in meetings in the absence of the member who appointed him or her. (Pub. Resources Code § 30304.)

## Term:

A person appointed by the Governor and qualified for membership because he or she holds a specified office as a locally elected official shall serve at the **pleasure of the Governor**. However, the membership shall cease sixty (60) days after his or her term of office as a locally elected official ceases, or when a person has been appointed to fill that position by the Governor, if that occurs sooner. (Pub. Resources Code § 30312(a)(1).)

A member appointed by the Governor shall serve for **two (2) years** at the pleasure of the Governor, and may be reappointed for succeeding two (2) year periods, provided that the member may continue to serve beyond the two (2) year term until the Governor has acted and the appointee is authorized to sit and serve on the commission. (Pub. Resources Code § 30312(b)(1).)

A person appointed by the Senate Committee on Rules, or by the Speaker of the Assembly and qualified for membership because he or she holds a specified office as a locally elected official shall serve a term of **four (4) years**. However, the membership shall cease sixty (60) days after his or her term of office as a locally elected official ceases, if that occurs sooner. (Pub. Resources Code § 30312(a)(2).)

A member appointed by the Senate Committee on Rules or the Speaker of the Assembly shall serve for four (4) years, and may be reappointed for succeeding four (4) year periods, provided that the member may continue to serve beyond the four (4) year term until his or her appointing authority has acted and the appointee is authorized to sit and serve on the commission. If the Senate Committee on Rules or the Speaker of the Assembly has not acted within sixty (60) days after the expiration of a member's term, the position shall become vacant until a person is appointed to a four

If the expected vacancy is a person qualified for membership because he or she holds a specified office as a locally elected official, whose term of office as a locally elected official is expected to expire or has expired, then the appointing authority shall notify the boards of supervisors and city selection committees of each county within the affected region of the expected vacancy. (Pub. Resources Code § 30313(b).)

Compensation: Notwithstanding any other provision of law, whenever a member or a board, commission, committee, or similarly constituted body created by executive order or statute, is authorized to receive a per diem salary or allowance in excess of expenses incurred by the member, that rate shall be established at one hundred dollars (\$100) per day unless a higher rate is provided by statute. This section shall not apply to those boards or commissions provided an annual salary in this chapter, not to the board specified in Section 1150 of the Harbor and Navigation Code. (Gov. Code § 11564.5.)

An alternate shall be entitled to payment and reimbursement for the necessary expenses incurred in participating in commission meetings; provided, however, that only the member or his or her alternate shall receive that payment and reimbursement, and if both the member and alternate prepare for, attend, and participate in any portion of a commission meeting, only the alternate shall be entitled to that payment and reimbursement. (Pub. Resources Code § 30314.)

For the purposes of this section, "full day of attending a meeting" means presence at, and participation in, not less than 60 percent of the total meetings time of the commission during any particular 24 hour period. (Pub. Resources Code § 30314.)

## COLORADO RIVER BOARD OF CALIFORNIA

Purpose: The Colorado River Board of California, within the Natural Resources Agency, is charged with maintaining or increasing the quantity of California's Colorado River water resources; representing California in discussions among the Colorado River Basin States, Indian Tribes, the federal government and others in implementing joint cooperative programs to protect California's use of Colorado River water and to address environmental and endangered species issues; and addressing issues relating to the 1944 U.S.-Mexico Water Treaty through cooperative efforts with the U.S. International Boundary and Water Commission and other states.

The CRB consists of eight members appointed by the Governor: representatives of the six California local water agencies that originally held Colorado River water rights, two public members, as well as the Director of Water Resources and the Director of Fish and Game or their designees. The six local water agencies are: Palo Verde Irrigation District, Imperial Irrigation District, Coachella Valley Water District, Metropolitan Water District of Southern California, San Diego County Water Authority, and the Los Angeles Department of Water and Power.

    - a. Student members from a submitted list of at least three (3) eligible persons submitted to the Governor by the student organization recognized by the board of governors.
    - b. Student members shall be enrolled in a community college with a minimum of five (5) semester units, or its equivalent, at the time of the appointment and throughout the period of his or her term, or until a replacement has been named. A student member shall be enrolled in a community college at least one (1) semester before his or her appointment, and shall meet and maintain the minimum standards of scholarship prescribed for community college students. (Ed. Code § 71000(b)(1)(A-C).)

The terms of the public members appointed pursuant to subparagraph (B) of paragraph (11) of subdivision (a) shall be for one year.

The terms of the public members appointed pursuant to paragraph (12) of subdivision (a) shall be for two years.

(1) Adopting a timeline for phasing in the data system, including a timeline for the development of analytical tools, operational tools, and offering professional development and technical assistance.

(2) Ensuring that the data system is serving its intended purposes by submitting recommendations to the Governor and the Legislature to adjust the data system's vision, mission, and strategic objectives, particularly recommendations related to improving educational outcomes and reducing opportunity gaps.

(3) Adopting and adjusting as necessary a data dictionary, data standards, and security protocols to ensure interoperability between the data system, the source data, and other state data systems using the same source data.

(4) Expanding the collected data set, beyond the P20W data set, by doing both of the following:

(A) Approving additional data providers.

(B) Requesting additional data points from data providers, in the context of data quality, legal concerns, costs, and preserving the neutrality of the data system. The governing board shall not require a data provider to collect data that the data provider is not legally allowed, under other applicable laws, to collect.

(5) Creating new analytical and operational tools that would help the public interact with the data.

(6) Creating, and revising from time to time, in consultation with the advisory boards, a data request process for use by researchers, policymakers, education systems, schoolsites, and college campuses for information that is all of the following:

(A) In compliance with federal and state laws to protect individual privacy.

(B) Not otherwise available via the public query tools maintained by the managing entity.

(C) Allows for expedited access to summary data that has been properly deidentified.

(D) Allows for data providers to approve data requests in the public interest, as defined pursuant to Section 10861.

(c) (1) The governing board shall be responsible for adopting best practice policies related to privacy and security, including creating policies, in accordance with federal and state law, governing the collection and use of personally identifiable information from data providers, which may include the creation of an “opt out” policy for students and families.

(2) This section does not hinder the use of personally identifiable information for educator- and student-facing college guidance and planning tools, defined as operational tools in Section 10851.

(d) The governing board shall provide oversight of the data system and operational direction to the managing entity to ensure the data

system is serving its intended purpose. This may include, but is not limited to, all of the following activities:

- (1) Adopting an annual strategic plan and reviewing and revising that plan as needed.
- (2) Approving budget requests for inclusion in the governing board's annual budget request.
- (3) Ensuring continued use of a user-centered design approach by the managing entity.
- (4) Reviewing and approving all of the following:
  - (A) End user professional development, and technical assistance and communications plans, as developed by the managing entity.
  - (B) An operational tools implementation plan, as developed by the managing entity.
  - (C) Recommendations for topics to be included in reports to provide a neutral summary of information available in the data system.
  - (D) Significant content changes to the analytical tools, such as dashboard visualizations and query builder data points.
- (5) Conducting data quality audits.
- (6) Providing for other audits and evaluations.
- (7) Adopting rules and exercising authority to promulgate regulations, including emergency regulations.
- (8) Any other activities necessary to further the intent of this chapter.
- (9) Providing regular reports to the Legislature and Governor related to the implementation of this chapter. The reports to the Legislature shall be submitted in compliance with Section 9795 of the Government Code.

(e) The governing board may create any other policies and procedures necessary to further the intent of this chapter.
