Lewis Baker

Lewis Baker, a resident of California, has applied for executive clemency.

On May 13, 1998, the Superior Court of California, County of Los Angeles, sentenced Mr. Baker to three years in prison for manufacturing a controlled substance and maintaining a synthetic drug. On July 23, 2001, the court sentenced Mr. Baker to four years and four months in prison for possession of a controlled substance for sale with a prior conviction.

Mr. Baker complied with the provisions of California Penal Code sections 4852.01 through 4852.22, which provide a procedure after completion of sentence to seek restoration of civic rights and responsibilities. On July 31, 2019, the Superior Court of California, County of Los Angeles, granted Mr. Baker a Certificate of Rehabilitation on evidence that he has been living an upright life. By granting Mr. Baker's petition for a Certificate of Rehabilitation, the court has recommended that Mr. Baker be granted a pardon.


The Board of Parole Hearings reviewed Mr. Baker's clemency application and voted at an en banc meeting to recommend a pardon grant. The California Supreme Court also reviewed his application and made a recommendation for a pardon grant, a process required by the California Constitution for cases in which the applicant has been convicted of more than one felony.

This act of clemency for Mr. Baker does not minimize or forgive his conduct or the harm it caused. It does recognize the work he has done since to transform himself and his past service in the United States Army.

On July 2, 1999, the court sentenced Mr. Casillas to three years of probation and 90 days in jail for possession of a controlled substance. On March 30, 1998, the court sentenced Mr. Casillas to five years of probation and 365 days in jail for second degree robbery.







Reginold Daniels

Reginold Daniels, a resident of California, has applied for executive clemency.

On September 21, 1988, the Superior Court of California, County of San Francisco, sentenced Mr. Daniels to four days in jail for giving false information to an officer. On January 5, 1990, the court sentenced Mr. Daniels to two years in prison for possession of a controlled substance. On December 19, 1991, the court sentenced Mr. Daniels to one year and four months in prison for felon in possession of a firearm. On July 20, 1993, the Superior Court of California, County of San Mateo sentenced Mr. Daniels to two years and four months in prison for the sale or transport of material in lieu of a controlled substance. On March 27, 1997, the Superior Court of California, County of San Joaquin sentenced Mr. Daniels to one year and four months in prison for possession of marijuana for sale and felon in possession of a firearm. On July 14, 2005, the Superior Court of California, County of San Francisco, sentenced Mr. Daniels to three years of probation and 37 days in jail for accessory. On May 27, 2009, the court sentenced Mr. Daniels to three years of probation and one year in jail for possession of a controlled substance for sale.

Mr. Daniels complied with the provisions of California Penal Code sections 4852.01 through 4852.22, which provide a procedure after completion of sentence to seek restoration of civic rights and responsibilities. On May 18, 2015, the Superior Court of California, County of San Francisco, granted Mr. Daniels a Certificate of Rehabilitation on evidence that he has been living an upright life. By granting Mr. Daniels's petition for a Certificate of Rehabilitation, the court has recommended that Mr. Daniels be granted a pardon.


