

# EXECUTIVE DEPARTMENT STATE OF CALIFORNIA

## PROCLAMATION OF A STATE OF EMERGENCY

**WHEREAS** between January 7, 2025, and January 8, 2025, the City of Rancho Cucamonga was impacted by severe windstorms ("January 2025 Windstorm Event"), with gusts exceeding 65 miles per hour; and

**WHEREAS** high winds caused severe damage to public infrastructure and private property throughout the City, including causing power outages, toppling trees, and damaging public facilities such as the historic China House; and

**WHEREAS** the Palisades and Eaton Fires began the same day in neighboring Los Angeles County and, combined with the high winds, resulted in conditions presenting extreme fire threat for the region; and

**WHEREAS** under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property existed due to impacts from the January 2025 Windstorm Event in the City of Rancho Cucamonga; and

**WHEREAS** under the provisions of Government Code section 8558(b), I find that the conditions caused by the January 2025 Windstorm Event, by reason of their magnitude, are beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

**WHEREAS** under the provisions of Government Code section 8625(c), I find that local authorities are inadequate to cope with the magnitude of the damage caused by the January 2025 Windstorm Event; and

**WHEREAS** under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of the January 2025 Windstorm Event.

**NOW, THEREFORE, I, GAVIN NEWSOM**, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in the City of Rancho Cucamonga due to the January 2025 Windstorm Event.

### IT IS HEREBY ORDERED THAT:


1. All agencies of the state government utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all residents are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.
2. The Office of Emergency Services shall provide assistance to local governments, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.

3. The restrictions set forth in Penal Code section 396, which are automatically triggered upon proclamation of a state of emergency, are suspended, and no such restrictions are imposed, with respect to the January 2025 Windstorm Event in the City of Rancho Cucamonga.

**I FURTHER DIRECT** that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.
