PROCLAMATION OF A STATE OF EMERGENCY

WHEREAS on August 24, 2025, a powerful storm event occurred in Imperial County and continued through August 25 ("2025 August Monsoon Storms"); and

WHEREAS the 2025 August Monsoon Storms produced heavy rain, high winds exceeding 58 miles per hour, and flooding, resulting in power outages throughout Imperial County and semi-trucks being overturned on Highway 86; and

WHEREAS the 2025 August Monsoon Storms caused significant damage to the electrical infrastructure of the Imperial Irrigation District, including approximately 400 transmission power poles and associated distribution infrastructure, as well as other public infrastructure such as canal banks, lined canals, public buildings, and equipment; and

WHEREAS under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to the 2025 August Monsoon Storms in Imperial County; and

WHEREAS under the provisions of Government Code section 8558(b), I find that the conditions caused by the 2025 August Monsoon Storms, by reason of their magnitude, are or are likely to be beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

WHEREAS under the provisions of Government Code section 8625(c), I find that local authority is inadequate to cope with the magnitude of the extreme peril posed by the 2025 August Monsoon Storms; and

WHEREAS under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of the 2025 August Monsoon Storms.

NOW, THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in Imperial County due to the 2025 August Monsoon Storms.

IT IS HEREBY ORDERED THAT:


1. All agencies of the state government utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all residents are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.

2. The Office of Emergency Services shall provide assistance to the Imperial Irrigation District, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.
3. The restrictions set forth in Penal Code section 396, which are automatically triggered upon proclamation of a state of emergency, are suspended, and no such restrictions are imposed, with respect to the 2025 August Monsoon Storms in Imperial County.

I FURTHER DIRECT that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.
