PROCLAMATION OF A STATE OF EMERGENCY

WHEREAS on July 29, 2025, at approximately 4:25 P.M. Pacific Daylight Time (PDT), a magnitude 8.8 earthquake occurred off the coast of the Kamchatka Peninsula in Russia; and

WHEREAS this earthquake generated tsunami waves of up to four feet which reached Crescent City in Del Norte County the morning of July 30, 2025 ("2025 July Tsunami"); and

WHEREAS the tsunami waves caused structural failure of the Crescent City Harbor District's "H" Dock, including complete separation of the dock, and subsequent wave surges left behind significant sediment deposits requiring extensive dredging to return navigation channels to pre-disaster conditions; and

WHEREAS under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to the 2025 July Tsunami in Del Norte County; and

WHEREAS under the provisions of Government Code section 8558(b), I find that the conditions caused by the 2025 July Tsunami, by reason of their magnitude, are or are likely to be beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

WHEREAS under the provisions of Government Code section 8625(c), I find that local authority is inadequate to cope with the magnitude of the extreme peril posed by the 2025 July Tsunami; and

WHEREAS under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of the 2025 July Tsunami.

NOW, THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in Del Norte County due to the 2025 July Tsunami.

IT IS HEREBY ORDERED THAT:

1. All agencies of the state government utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all residents are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.

2. The Office of Emergency Services shall provide assistance to the Crescent City Harbor District, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.
3. The restrictions set forth in Penal Code section 396, which are automatically triggered upon proclamation of a state of emergency, are suspended, and no such restrictions are imposed, with respect to the 2025 July Tsunami in Del Norte County.

I FURTHER DIRECT that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.
